The meeting was convened at 50 Park Place, Newark, New Jersey, at 5:00 P.M.

**WHEREAS**, the Parking Authority of the City of Newark opted at its November 2013 Board of Commissioners Meeting to award contracts for Professional Services under a Fair and Open Process, as defined in *N.J.S.A.* 19:44A-20.4, *et seq.*, in the year 2014 for the following Professional Services:

Parking Consultant; and,

Bond Counsel; and,

Financial Advisor; and,

Auditor; and,

Accountant; and,

Garage and Related Facilities Engineering Services; and,

Conflict Counsel; and,

Outside Counsel; and,

IT and computer related services; and,

whereas, a Request for Qualifications for each of the above professional positions with the exception of the Auditor position was advertised on February 7, 2014 pursuant to the said statutes on the Internet and designated newspapers of general circulation on February 7, 2014; and,

**WHEREAS**, the Parking Authority of the City of received numerous Responses to the said Requests for Proposals which have been opened in accordance with the Bid Instructions and determined to be complete; and,

whereas, because the process of advertising and opening was delayed substantially because of inclement weather which caused closures of the office, and because of two (2) legal holidays, which left insufficient time for the Board of Commissioners to fully review the evaluations of the Evaluation Team and to review the numerous Responses themselves prior to the February 27, 2014 proposed award date at its February 2014 Board Meeting, the Board of Commissioners of the Parking Authority of the City of Newark took the Responses under advisement and full review and evaluation for consideration and award at the March 2014 Meeting of the Board of Commissioners; and,

WHEREAS, contracts for Special Counsel, Parking Consultant, Garage and Related Facilities Engineering and for Sports Arena Management and Administration were awarded in accordance with the Local Public Contracts Law at the Board Meeting of March 20, 2014; and,

WHEREAS, the Board of Commissioners was unable to meet in April for the scheduled Board of Commissioners meeting due to quorum issues, thus preventing any actions being taken in conformity with the 60 day requirement of the Local Public Contracts Law; and,

whereas, certain projects in the planning stages of the Parking Authority of the City of Newark do not presently require the immediate appointment of professionals or the awarding of contracts at this time, which was specifically permitted in the terms of the published Request for Proposals for Bond Counsel, Financial Advisor and Special Counsel:

**NOW, THEREFORE, BE IT RESOLVED** by the Parking Authority of the City of Newark that no award of Bond Counsel, Financial Advisor, or Special Counsel shall be made in accordance with the terms of the published Request for Proposals for such contracts; and,

IT IS FURTHER RESOLVED, that if and when such positions are re-advertised, then any Respondent who submitted a response on February 21, 2014 who wishes to respond again shall not be required to re-submit a complete Response to Request for Proposals except as to any information, including but not limited to cost proposal, which has changed since the Respondent's prior proposal, upon submission of a letter indicating that they wish to be considered; and,

IT IS FURTHER RESOLVED, that the Executive Director or his designee shall provide notice of the same to all Respondents in a timely fashion in accordance with the Local Public Contracts Law.
