Chairperson Raquel Cagley noted that there was a quorum present and the Board was in accord with State Statute and the meeting could now commence.

Executive Director Mack gave an due on the staffing issues presented by COVID-19. Director stated the essential staff has been coming in and also working from home. The Executive Director speaks daily with the Director of Enforcement and the small staff we have coming in. Summonses are being issued only for public safety violations. We average 25 to 30 summonses per day. The Director further reported that we consistently sanitize are vehicles. The authority has about ninety (90) days of PPE supplies, i.e. gloves, masks, hand sanitizers. We are in the process of purchasing more, which is a challenge in and of itself.

Executive Director Mack further advised the Board that the Authority is still in compliance with the Mayor's "Be Still Mondays" and will continue to do so until he announces that it is discontinued. The Authority work days are currently

Monday through Tuesday. In addition, we have a telephonic staff meeting every Monday morning at 10:00am. Commissioner Lewis inquired about social distancing. Director advised that we are, in fact, practicing social distancing. No one shares desks, phones or supplies.

Director Mack reported that our revenue has diminished substantially and provided comparison of what we collect now to what we have collected in the past. Director also advised that we have had a couple of meters vandalized, but, for the most part, it has not been too bad in that area.

There was no Legal report and no further report from the Executive Director

Commissioner Allen recognized and praised the efforts of the Executive Director, General Counsel and staff during this most difficult time and the entire Board agreed,

There being no further business, the meeting was adjourned at 6:16 on motion of Commissioner Allen seconded by Commissioner Parrillo and approved by unanimous consent.
