**WHEREAS**, the Parking Authority of the City of Newark is a public body corporate and politic of the State of New Jersey;

WHEREAS, the Parking Authority of the City of Newark entered into an Interlocal Agreement with the City of Newark on August 6, 2008;

WHEREAS, Section 405 of the Interlocal Agreement between the City of Newark and the Parking Authority of the City of Newark gave the Authority the right to "govern the use of On-Street parking spaces and meters by posting reserved parking signs or the bagging of meters and collecting fees for the placement of such reserved parking signs or bags over meters that are blocked by construction/demolition dumpsters/vehicles, carting/moving vehicles, or designated special events and any other purpose that requires the reservation of On-Street parking spaces and meters";

**WHEREAS**, the Parking Authority of the City of Newark has been charging twenty-five (\$25.00) dollars per day to reserve each metered parking space, while authorizing the Executive Director to negotiate rates for long term construction and/or other development use; and

**WHEREAS**, the costs associated with reserving each metered parking space has increased; and

WHEREAS, the Executive Director recommends that the reservation rates should Increase from twenty-five (\$25.00) dollars to thirty-five (\$35.00) dollars.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Commissioners of the Parking Authority of the City of Newark will increase the reservation rates from twenty-five

(\$25.00) dollars to thirty-five (\$35.00) per day to reserve each metered parking space, while still authorizing the Executive Director to negotiate dally rates for long term construction and/or other development use.

**WHEREAS**, the Parking Authority of the City of Newark (the "Authority"), is a public body corporate and politic and a political subdivision of the State of New Jersey and is subject to the authority of the Local Finance Board pursuant to the Local Budget Law, *N.J.S.A.* 40A:4-1, et seq. and/or the Local Authorities Fiscal Control Act, *N.J.S.A.* 40A:5A-1, et seq.; and

**WHEREAS**, the Authority has previously adopted an Employee Handbook setting forth the policies and procedures of the Parking Authority of the City of Newark, which does not constitute a contract of employment; and

WHEREAS, the Employee Handbook provides a specific Vacation Leave Policy;

**WHEREAS**, the Employee Handbook states:" Vacation leave allowed for any given year should be used during that year. Any unused vacation leave may be carried over into the next succeeding year only for reasons of business necessity and only then with the prior written approval by the Executive director. Carried over vacation must be used in the next succeeding year; if the carried over vacation days are not used in the second year, they will be forfeited; and

**WHEREAS**, there is a substantial number of employees who would need to take a significant amount of vacation days; and

**WHEREAS**, if employees, particularly the parking enforcement officers, were to take their vacation at the end of the year, it could present a significant decrease in enforcement revenue; and

WHEREAS, if the employees were given an option to "cash out" up to ten (10) vacation days, based upon their salary rates, employees would be available to work and assist in enforcement revenue, and other duties necessary to maintain the Newark Parking Authority; and

**WHEREAS**, the Executive Director recommends providing this cash out option to all employees eligible; and

WHEREAS, the Financial Manager has certified as to the availability of funds for the purposes intended herein from the current budget.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Parking Authority of the City of Newark approving the recommendation of the Executive Director to provide a "cash out" option up to ten (10) vacation days to employees not used by December 31, 2021.
